**NOTE:** Parents or legal guardians must prove the minor STUDENT will have the care and support they need during their stay in Canada and while studying at the University of Calgary. Students under the age of 18 must:

- have submitted a copy of the completed Government of Canada Custodianship Declaration form if they are 16 years of age or less to the University of Calgary Registrar; or
- be residing with their parent(s) or legal guardian(s) in Canada; or
- have submitted this completed Parent/Guardianship Custodian Declaration form to the University of Calgary Office of the Registrar ([esdocs@ucalgary.ca](mailto:esdocs@ucalgary.ca)).

**A custodian is a responsible adult, who is a person over 19 years of age, who will take care of and support the underage student.**
